### Terms and Conditions

1. The Horse Racing Club - First Past The Post Service is administrated by our sister company Cheltenham Associates Ltd and this is the reference which will appear on your credit or debit card statement.
2. Telephoning The Horse Racing Club - First Past The Post Service to receive the information will be taken as an agreed contract that you agree to pay Cheltenham Associates Limited the fee of £5 per winning selection. Monies due will be invoiced weekly at £5 per successful selection via e-mail for payment by credit/debit card through the Paypal service. If you do not have an e-mail address you will be invoiced by post to your registered address for payment via cheque. This will be charged regardless of whether or not the registered person places a bet on the selection if the selection wins.
3. If you have a Paypal account you can log on to it from our invoice and pay securely. You do not need to have a registered Paypal account in order to pay our invoices as the service allows you to securely enter your credit/debit card details in order to pay.
4. The Horse Racing Club will make every effort to ensure that the information passed on is of the highest possible quality however we cannot guarantee that every bet will win and future performance cannot be based on any past results that the service has achieved in the past – Members of The Horse Racing Club and the First Past The Post Service should be aware of this and as with any other form of gambling they should bet responsibly and accordingly at all times within their means.
5. The Horse Racing Club and Cheltenham Associates Ltd cannot guarantee that any profits will be made from the services offered and therefore take no responsibility for any member's personal monetary losses.
6. Cheltenham Associates Ltd reserves the right to refuse any application for registration to the First Past The Post Service and furthermore reserves the right to terminate a member's registration should that member act in a manner that is detrimental to the service.
7. Members are requested to not telephone the Cheltenham Associates Ltd office except to discuss their personal account matters. Our staff are available to provide an information service but are not qualified to discuss ANY betting queries or discuss the relative chances of selections and Cheltenham Associates Ltd reserves the right to terminate a member's registration should that member abuse it's staff either verbally or in writing.
8. Cheltenham Associates Ltd is not responsible for any disruptions in service caused by a failure of computer or telephonic equipment.
9. The Horse Racing Club - First Past The Post Service information is intended for the sole use of the member and should not be passed to third parties. Cheltenham Associates Ltd reserves the right to terminate the registration of a person believed to be re-selling information.
10. Invoices will be sent weekly via e-mail or through the post which should be settled immediately. Payments are taken securely via Paypal and will show up on the member's statement as "Paypal Cheltenham". If you are paying by cheque please make cheques payable to "Cheltenham Associates Limited"
11. Remember, please allow for processing time - transactions will appear on your statement 3 – 5 days after the invoice was sent. You should keep your own records of information that you agree to take and pay for.
12. To be registered as a member of this service you must be over 18 years of age.
13. If a member defaults on a payment transaction the member's access to First Past The Post information service will be blocked until the member's account is brought back into order.
